Overview

B2B has CoP validations applied for new <u>UK/GBP recipients only</u>.

CoP validations will result in either 'Full Match' or 'No Match' or 'Partial Match'.

Full Match - Details provided are validated and resulted in a 'Match'. Recipient will be created successfully.

Note: here the creation flag (allowPartialMatchCreation) is disregarded

No Match - Details provided are validated and resulted in a 'No Match'. Recipient cannot be created as validations failed. Error(s) and meta data is returned in the response.

Note: here the creation flag (allowPartialMatchCreation) is disregarded

Partial Match - Details provided are validated and resulted in a 'Partial Match'. Recipient creation will depend on the value given for 'allowPartialMatchCreation' element in the request.

create recipient endpoint:

- "allowPartialMatchCreation": true Continue creating recipient with the details provided (partially matched) and accept the risk that payment may go to the wrong account and we might not be able to get it back. Recipient will be created.
- "allowPartialMatchCreation": false Recipient will not be created with the details provided (partially matched)

validate recipient endpoint:

• "allowPartialMatchCreation" is disregarded, meaning that even if the flag is set to True, the response from the validation will be 400 BadRequest

Recipients can be created using either AccountNumber + SortCode combination, or IBAN+SwiftBic. Examples are given with both combinations.
