Overview

B2B has CoP validations applied for new UK/GBP recipients only.

CoP validations will result in either 'Full Match' or 'No Match' or 'Partial Match'.

Full Match - Details provided are validated and resulted in a 'Match'. Recipient will be created successfully.

Note: here the creation flag (allowPartialMatchCreation) is disregarded

No Match - Details provided are validated and resulted in a 'No Match'. Recipient cannot be created as validations failed. Error(s) and meta data is returned in the response.

Note: here the creation flag (allowPartialMatchCreation) is disregarded

Partial Match - Details provided are validated and resulted in a 'Partial Match'. Recipient creation will depend on the value given for 'allowPartialMatchCreation' element in the request.

create recipient endpoint:

- "allowPartialMatchCreation": true - Continue creating recipient with the details provided (partially matched) and accept the risk that payment may go to the wrong account and we might not be able to get it back. Recipient will be created.
- "allowPartialMatchCreation": false - Recipient will not be created with the details provided (partially matched)

validate recipient endpoint:

- "allowPartialMatchCreation" is disregarded, meaning that even if the flag is set to True, the response from the validation will be 400 BadRequest

Recipients can be created using either AccountNumber + SortCode combination, or IBAN+SwiftBic. Examples are given with both combinations.



The two endpoints which are related to the COP validations in B2B are **Create Recipient** (version 1 and 2) and **Validate Recipient** (version 1 and 2)

Create Recipient:

This endpoint will create an individual recipient, associated to a specific Account ID. This recipient can then be used to create a payment against using the Create Payment endpoint. Recipient details are validated prior to creation, any errors will be returned back with a description of any problems found during validation. To see what fields are required for a given recipient country/currency combination use the Get Recipient Requirements endpoint.


